THE NIAGARA COUNTY LEGISLATURE REAFFIRMS OUR SUPPORT OF THE 2ND AMENDMENT

WHEREAS, the Niagara County Legislature has consistently gone on record unanimously opposing New York States infringement on an individual's 2nd amendment "right of the people to keep and bear arms", and

WHEREAS, resolutions IL-011-13 unanimously opposing the controversial "SAFE Act", IL-006-13 unanimously opposing the pistol permit registration and Il-036-11 unanimously opposing Microstamping are a few examples of such reaffirmations of our 2nd Amendment rights, and

WHEREAS, this Niagara County Legislature will continue to oppose any infringement on the 2nd Amendment such as, but not limited to, long-gun/hunting/sporting gun registry or Firearm Owner Identification Card (FOID card) and/or requiring gun owners to purchase insurance for each gun legally owned, now, therefore, be it

RESOLVED, that this Niagara County Legislature goes on record reaffirming our support of the 2nd Amendment which states " A well regulated militia, being necessary to the security of a free state, the right of the people to keep and Bear Arms, shall not be infringed", and be it further

RESOLVED, that the Clerk of the Legislature shall forward certified copies of this Resolution to the Governor of the State of New York Andrew Cuomo, Senate Majority Leader John Flanagan, Senator Robert Ort, Speaker of the New York State Assembly Carl Heastie, Assembly Minority Leader Brian M. Kolb, Assemblyman Angelo Morinello, Assemblyman Michael J. Norris and others deemed necessary and proper.






